Dear Cross Country Coach,

This year's Boys and Girls District Cross Country Meet will be held on Saturday, October 24, 2009 at the Miami Valley Career Tech Center in Clayton, OH.

If your school is not going to participate in this year's meet, you must contact the O.H.S.A.A. office in Columbus and inform them immediately.

**State Eligibility Sheets-** please mail or fax your state eligibility form(s) to me (937-506-8363). These state eligibility forms must be received by Saturday, October 17, 2009. Secure these forms from your athletic director. Only runners whose names appear on the O.H.S.A.A. eligibility forms may compete in the district meet. Make sure all potential runners are listed. You are permitted to make substitutions on race day, provided these runners are listed on your O.H.S.A.A. state eligibility form.

**Team Pass List-** please fill out the team list page and either fax it to me (937) 506-8363 or bring it race day. This list will be your pass list for admittance to the meet. You may include up to 13 athletes and 2 coaches. You can download the pass list form at: <http://www.alliancerunning.com/SWDistrict.htm>.

**On-line Entry Process-** once again the district will be using Baum's Page for collection of data and posting of results. On-line entry directions are contained on a separate page included in this mailing. Your on-line entries are due by 8:00 p.m. on Monday, October 19, 2009.

Division I Races- 4 teams from each race and 16 individuals

Division II Races- 4 teams from each race and 16 individuals

Division III Races- (Girls) 6 teams from one race and 24 individuals (Boys) Race A- 4 teams and 16 individuals Race B- 4 teams and 16 individuals

**Seeding Process-** all teams in the Dayton Division I races will be seeded. Each race will be balanced as to the number of participants. Coaches will be sent voting instructions and all votes must be received by the meet manager on Friday, Noon, October 9, 2009.

**Tournament Placement Meeting-** will be held on Sunday, October 11, 2009, 2:00 p.m. in the Cafeteria at Tippecanoe Middle School for Division I schools. DII will be in the Library.

**Admission-** there will be a \$6.00 general admission charge to the district meet. Please advise all parents and interested spectators of this admission.
